COURSE OVERVIEW

This entire course is conducted online via Zoom. This course is designed for law enforcement personnel who are responsible for deploying in the capacity as a Crisis Negotiation Team Leader or as a supervisor who is responsible for the training and deployment of crisis negotiation teams. The focus of this training will be on pre-incident training, planning, organizing, and the decision-making process used in the resolution of crisis negotiation operations. Also included in the curriculum is an overview of negotiation training topics including selection and testing, training issues and liability, national CNT standards and critical incident reviews. The student will learn negotiation strategies from actual incident debrief/case studies, class discussions, and practical exercises/scenarios.

# NOTE: Students are required to have a computer, or tablet with BOTH microphone and webcam capabilities to participate in this class.
