School safety

As we progress further into the year, we are once again reminded of our need to remain vigilant and be prepared. Active shooter incidents continue to haunt law enforcement even as we work to improve our capabilities. Many so-called experts have offered "solutions" that are divisive and don't improve

safety. I strongly encourage each of you to take an active role in examining proactive measures that really do make our communities safer, especially our schools. This includes "hardening" schools, school staff training, and legislation to establish standards.

I think we can agree that we need a national standard on school safety regarding active shooters, similar to fire drills. The NTOA is working to establish minimum school safety standards to achieve this goal. These standards are derived from after-action analysis of five of the most notorious active shooter events. Each step will help reduce the potential for human failure and loss of life.

No doubt this effort will take time to create and implement. Few are as qualified as each of you to play a part in establishing a local standard as we work toward a national plan. Reach out to local school districts, parent-teacher associations and command staff to identify ways to work collaboratively to create plans that assist schools in improving their capabilities to "self-help" prior to law enforcement arrival.

Too often, we re-evaluate our response to active shooter incidents at the expense of focusing on the time before the response. This gap between time of call received and arrival is where we need to improve. Please use this "good" time to make a difference.
